AGREEMENT

This Agreement is made on this ----- day of ----- -- between the Director, Indira Gandhi National Forest Academy (IGNFA), Dehradun herein after called Director and M/S. -----

The Director, IGNFA on the basis of covenants stated here under agrees to award order of supply of periodicals stated in ANNEXURE – I & II for the Indira Gandhi National Forest Academy Library, herein after called IGNFA Library to M/S. -----
-----for a period as indicated against each periodical. Whereas the supplier has agreed on the basis of the following mutual covenants:

1. The supplier shall supply to the IGNFA Library, Deharadun a copy of all the issues of the periodicals in original sated in Annexure – I & II within six weeks of publication thereof, arrange their on-line version, if available free of cost with the print version, and provide all necessary assistant like subscription reference numbers, etc. required for accessing the said periodicals on – line. In case the on-line access is available via IP address of IGNFA shall be registered with the publisher.
2. The Supplier shall produce within reasonable time of signing the contract –
 - (a) A Certificate from the bank proof of transferring the payment to the concerned agencies by the supplier.
 - (b) Copies of price proof of each periodicals stated in Annexure I& II
 - (c) Copy of prevailing Bank conversion rate at the time of making payment to the concerned agencies by the supplier.
 - (d) Subscription references nos. for IGNFA orders for cross checking with the concerned agencies to ensure that the orders have actually been placed in the name of IGNFA.
3. The IGNFA will make payment to the supplier after receipt of all the documents etc. in point 2 above.
4. The supply shall start within Four to eight weeks of signing of the contract.
5. The supplier shall ensure safe and secure delivery of the periodicals stated in Annexure I & II
6. The supplier shall remit equivalent amount of price of periodical in the event of non-receipt of any of the issues of periodicals stated in Annexure I & II through a demand Draft and shall take full responsibility of any loss sustained by IGNFA on account of any mutilation caused to any issue of periodicals either in transit or otherwise.
7. The supplier shall within a period of 15 days from the date of award of the contract deposit a security / bank guarantee of 10%(in Favour of the Director, IGNFA, Dehradun) of the total

order value of the periodicals, stated in Annexure – I & II for a period of one year from the date of signing the contract.

8. When there is a reason to believe that supplier is engaging in unhealthy practice or breach of any conditions stated above, the Director, IGNFA shall be at liberty to terminate the contract and bar the supplier from supplying to IGNFA in future.
