You may quote against this tender enquiry only if you are a manufacturer/distributor of KABUL PAL Tents authorized dealer/distributor. If you quote in violation of these conditions your earnest money deposit will stand forfeited.

The Technical Specifications of the KABUL PAL Tent along with accessories, to be purchased are enclosed in Annexure-I. The estimated quantity required would be 16, which may be increased/decreased as per the discretion of Director, IGNFA.

The terms and conditions governing the tender for supply of KABUL PAL Tents are given in Annexure-IV.

Tenders have to be submitted in sealed covers containing **separate technical and financial bids** in the prescribed formats as enclosed in appendices II and III in original, issued from the office of the Director, IGNFA, New Forest, Dehradun, Uttarakhand. It may be noted that the two bid system shall be followed and the tenderer must submit technical and financial bids separately in a sealed envelopes simultaneously along-with EMD AND other annexures as provided (Tender booklet) shall be placed in an outer envelope and sealed. It should reach IGNFA not later than 1500 hours IST on **17.01.2018**. Both inner envelopes shall also indicate the name and address of the party submitting the tender (Tenderer). The other inner envelope shall contain the financial proposal duly identified as such. If the envelopes are not sealed and marked as instructed, MoEF&CC/IGNFA will assume no responsibility for the misplacement or premature opening of the proposals submitted. Bids received after the above date and time will not be entertained.

Technical bids must be submitted in one copy clearly marked as such. Technical Proposals must be sealed in a specially marked envelope/package marked "Bid 01-2018 – TENTS / TECHNICAL". Financial bids must be submitted in one separately sealed envelope, marked "Bid No- 01-2018 TENTS/ FINANCIAL".
