General Terms & Conditions: -

- 1. Physical Training Professionals shall be engaged on contract for the period of Two Years Extension beyond two years will be subject to the approval of competent authority and satisfactory performance of the employee.
- 2. Physical Training Professionals shall not be entitled to any allowances such as Dearness Allowance, Residential Telephone, Residential Accommodation, Personal Staff, CGHS, Medical Reimbursement etc.
- 3. Physical Training Professionals shall be allowed TA, DA and hotel accommodation in connection with the official work as per the provisions of SR 190.

Absence & Leave provisions: -

- i. Physical Training Professionals shall be eligible for 8 days leave in a single Year.
- ii. The leave shall accrue to them on completed month basis calculated from their date of joining on pro-rata basis.
- iii. Physical Training Professionals shall not draw any remuneration in case of his/her absence beyond 8 days in a year (Calculated on Pro-rata basis)
- iv. Un –availed leave in tenure of single year cannot be carried forwarded to next tenure of 1 year.
- v. The intervening Saturdays /Sunday or Gazetted Holidays during a spell of leave not be counted against the permitted leave period

Attendance & Working days: -

- i. The working hours of the Physical Training Professionals shall be as per the swimming schedule notified by Academy. No extra remuneration shall be allowed for working beyond office hours or on Saturday /Sundays/Gazette holidays. Compensatory leave in such cases shall be the discretion of the Officer in-charge Sports.
- ii. The attendance shall be marked in the biometric system by the Physical Training Professionals.

Integrity Certificate: - Selected Candidates shall provide integrity certificate from 2 reference known to them.

Conflict of Interest:

- i. Physical Training Professionals shall be expected to display utmost honesty, secrecy, sincerity and good conduct while discharging his/her duties. In case services of Physical Training Professionals found in conflict with interests of Government or unsatisfactory, his/her engagement will be liable for discontinuation without assigning any reason;
- ii. During the period of assignment with IGNFA, the Physical Training Professionals would be subject to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by him during the period of his assignment to anyone who is not authorized to know the same.
- iii. A self-undertaking shall be provided by the candidate to the effect that he/she has no criminal record or criminal case in any court is pending against them.
- iv. In case of retired persons this employment shall not be considered as reemployment.
- v. Person appointed on contract basis can be assigned, in additional to the specific task for which appointed, or other duties by the Director, IGNFA.
- vi. The appointment can be discontinued with one month notice by either side without assigning any reason. Also, the appointee shall not have any claim whatsoever for regular appointment on any position on the basis of contractual appointment.
- vii. The appointing authority for such appointments will be the Director.
