INDIRA GANDHI NATIONAL FOREST ACADEMY

Guidelines concerning the Indian Forest Service (Probationers) Final Examination made under the Indian Forest Service (Probationers Final Examination) Regulations 2016

PART-I

In exercise of powers conferred under regulations 3(1), (2), (3) and 4 of the Indian Forest Service (Probationers' Final Examination) Regulations, 2016 of the Ministry of Personnel, Public Grievance and Pensions (Department of Personnel & Training), Government of India vide Notification No. GSR-270 (E) dated 29-02-2016 and in supersession of all the previous guidelines the Director, Indira Gandhi National Forest Academy (IGNFA), Dehradun lays down the following guidelines for conduct of examinations and award of internal assessment marks with immediate effect:

A. GENERAL

- 1. The designated Course Director shall finalize the duration of two professional phases of training period, in accordance with the Indian Forest Service (Probationers' Final Examination) Regulations 2016, in consultation with Course Professor, Controller of Examinations and Director. Further each phase shall be divided into 2 terms each totaling 4 terms for two phases for the purpose of final examinations as given in Annexure-I.
- 2. (a) The final examinations comprise the following:
 - (i) Written and practical examinations;
 - (ii) Exercises and tours;
 - (iii) Qualifying tests.
 - (b) The examinations for the subjects covered during a term will be held in not more than two groups. The schedule of examinations will be notified well in advance.
 - (c) If any Probationer misses any final examination due to sickness or other causes over which he has no control; he/she will be allowed to appear at the next final examination or any special examination which the Director may hold for the purpose.
 - (d) If any Probationer fails to obtain fifty percent marks in each exercise or each tour or each group of subjects he/she may be allowed to appear in the re-examination (only once) which the Director may hold for the purpose. The Probationer will appear in the re-examination only in the subject or tour exam or exercise in which he/she failed. However, the marks awarded to him/her on such re-examination shall not be taken into account in determining the seniority.
- 3. As per the Regulations 11 of the Indian Forest Service (Probationers) Regulations, 1968, the seniority of Probationers shall be determined on the basis of the marks obtained by each Probationer, calculated in the manner specified below:
 - (a) Full aggregate marks in the competitive examination conducted by the Union Public Service Commission (UPSC), Govt. of India.
 - (b) 50% of the aggregate marks in the Final Examinations at IGNFA (1600 marks) and in the Foundation Course (75 marks).

- (a) The Probationers shall be assessed as per the syllabus mentioned in the first schedule and for the maximum marks allotted for each subject as mentioned in section 4 (a) of the above regulations. The mode of assessment for the written examinations shall be both by —Examinations (summative assessment) and Periodical concurrent assessment during the time of conduct of the course of the concerned subject through assignments, presentations, Group discussion, unannounced written quiz poster presentations etc. The weightage for the concurrent assessment for subjects shall be subject to a maximum of 30% of the total marks allotted to the subject, the mode and actual weightage for concurrent assessment in each subject shall be decided by a committee consisting of the Course Professor, Course Director and the concerned Faculty taking up the subject.
- (b) All Probationers shall maintain an attendance of at least 80% in each subject to appear in the Final Examination. The Probationers who fail to attain the stipulated 80% attendance in any of the subject shall have to appear in the final examination of the subject in which he/she has shortage of attendance with the subsequent training course(s) of Indian Forest Service Probationers. However, the Director IGNFA may relax this provision at his discretion under rare and exceptional circumstances.
- (c) No leave will be granted to the Probationers during examinations except for reasons due to sickness and other reasons over which he/she has no control.
- (d) The Course Director will inform the Controller of Examinations at least one month in advance regarding the completion of a course/subject and indicate tentative dates for the proposed examination.
- (e) The Examiners shall be responsible for setting up of question papers for various examinations at least two weeks in advance. The maximum marks for each subject shall be 100 (to be reduced as per the existing regulations) and the duration may vary from 90 minutes to 180 minutes.
- (f) Results of all the examinations are to be declared within a period of two months from the date of examination.

C. ASSESSMENT OF TOURS AND EXERCISES

- 5. The Probationers will be assessed for exercises and tours mentioned in the section 4(b) Part-II of the Indian Forest Service (Probationers) Regulations 2016 for maximum marks allotted for each tour and exercise as mentioned in section 4 (b) of the above regulations.
 - (a) Any Probationer whose attendance falls below 90% during any of the tours or exercises shall have to repeat the entire tour or exercises. Partial touring along with the subsequent courses, to make up for the missed tours or exercises, would not be allowed. Since the Probation period for IFS is for two years, the aforesaid permission to repeat the tour or exercise etc. shall be subject to approval of Director, IGNFA.
 - (b) Tour examination and tour symposium will be conducted after the completion of tour along with the submission of tour journal and herbarium by Probationers. No Probationer shall miss the tour examination or the tour symposium. Ordinarily, there will be no special examinations for the tour. However Director, IGNFA may relax this provision at his discretion to hold special examination under rare and exceptional circumstances.
 - (c) The marks for exercises and tours are further divided as per following details:

*** The assessment of Probationers in respect of 'Personality Development' for 75 marks shall be done by a committee comprising Professor (Academics), Course Director, Vice President (Club), Officer-in-Charge (Mess) and Controller of Examination. Performance indicators given in Part II of Schedule I of the Indian Forest Service (Probation) Regulations, 1968 shall be considered for this assessment.

^{**} Committee would be headed by Professor (Academics) and all the faculty members who were associated in teaching in the phase concerned would be the members.

- (1a) As the tours and exercises are likely to overlap with two phases, there shall be a separate assessment in respect of them and as far as possible the marks shall be displayed at the end of the tour/exercise. For the remaining 175 marks, phase-wise internal assessment shall be done by the Faculty concerned.
- (1b) The assessment of conduct on Tours and Exercises shall be done by the accompanying Faculty members, generally, in proportion to their duration in the tour. For tours and exercises the distribution of marks is given below:

- (4) (i) The assessment of Probationers in respect of PT & Games shall be done by Officer In Charge (OIC) PT & Games. For PT & Games separate guidelines would be issued from time to time. Marks for PT & Games shall be awarded out of a total of 40 marks. Weightage would also be given for being in Academy team and on winning medals in different tournaments.
 - (ii) Physical fitness shall be assessed for a maximum of 20 marks twice during the training in the Academy and average of the two assessments will be taken for final evaluation.
 - (iii) For Special achievement of Probationers a maximum of 4 marks shall be awarded twice during the training in the Academy and average of the two assessments will be taken for final evaluation.
 - (iv) Attendance in P.T and Games shall be assessed for a maximum of 16 marks twice during the period of training in the Academy and the average of the two assessments will be taken for final evaluation. All the Probationers shall maintain a minimum of 80% attendance in PT and Games. The Probationers who fail to attain the stipulated attendance, shall not be assessed for physical fitness for that Professional Phase and the marks awarded for physical fitness as well as for attendance will be zero (0).



Attendance in P.T. and Games shall be assessed as per the criteria given below.

E. PROCEDURE FOR DEDUCTION OF MARKS IN INTERNAL ASSESSMENT

- (a) On being reported for misconduct, the Course Director shall issue a show cause notice to the Probationer concerned directing him/her to explain the conduct within a specified period. Failure to explain or give a satisfactory reply will attract a fine of up to 05 marks at one time by the Course Director.
- (b) In case of serious misconduct, the Course Director may propose to Course Professor enhanced punishment and if deemed fit by the latter, up to 10 marks can be deducted at one time.
- (c) The marks so deducted under paras (a) and (b) above shall be communicated to the concerned Probationer and to his/her Counsellor and the Controller of Examination.
- (d) The marks mentioned at E (a) and E (b) will be deducted from the overall internal assessment of the Probationers.
- (e) Decision of the Director in internal assessment shall be final.

F. QUALIFYING TESTS

(a) Every Probationer have to undergo all qualifying tests/activities mentioned in the section 5 of the Indian Forest Service (Probationers) Regulations 2016 (listed below) and to appear in all these tests.

(b) A Probationer is required to get at least 50% marks in the group of qualifying tests.

(c) In case a Probationer fails to obtain 50% aggregate marks in the group of qualifying tests, he/she may not be awarded diploma. However, the Director has discretionary power in this regard.

- (b) Only those probationers will be eligible for the prizes against whom no disciplinary proceedings as defined in All India Service (Conduct) Regulations, 1968 are taken during the probation period in the academy.
- (c) * In view of increasing prices of gold and lower interest rates offered by the banks, the prize amount may be reduced suitably.
- (d) ** 1. 'Communication Skill' shall mean the ability to communicate what one wants to convey either orally or in writing to the other person or group of persons.
 - 2. Communication Skills of Probationers are proposed to be assessed as mentioned below:
 - (i) Tour Symposia 40% weightage.
 - (ii) Special events 40% weightage. There will be three oral and one written events and the marks will be decided by a Jury. The oral events will include elocution, declamation/debate and a panel/group discussion. Besides this, one book review will be carried out by the Probationers.
 - (iii) Peer assessment will have 20% weightage and will be done two times during the stay of Probationers in the Academy.
