Sub: Nomination of Indian Forest Service (IFS) officers for Mid-Career Training (MCT) Phase – IV (15) programme – regarding.

Sir,

This is to inform that in accordance with the existing MoEF&CC and DoPT, Gol guidelines, the 15th Course of the Phase – IV of the Mid-Career Training (MCT) programme for IFS officers of 2007 and 2008 YoA (14 – 16 years of service), the IFS officers of 2003, 2004, 2005 and 2006 YoA, who missed the past courses and the IFS officers who have recently completed Professional Skill Up-gradation Course (PSUC) after induction into IFS on promotion from SFS is being organized by Indira Gandhi National Forest Academy (IGNFA), as per the following schedule:

2. The IGNFA has enlisted the eligible IFS officers for the aforesaid Course. It is to be noted that the officers having less than three years of service left after the year in which he/she is slotted to undergo the Phase – IV MCT as well as those who have not completed PSUC after induction into IFS on promotion from SFS have been excluded. Accordingly, a list of 82 officers has been finalized. The complete list of the <u>78</u> officers, for whom the registration has been opened, is attached as Annexure – 'A'.

The <u>04</u> officers who had missed the earlier two offers to participate in the MCT Phase – IV programme, need to approach the MoEF&CC, Govt. of India, through the State Government for seeking approval for the third offer. The list of such officers is attached as Annexure – 'B'.

3. As the above training programmes are being organized in association with National/International institutions, participation of individual officer needs to be confirmed well in advance both by the concerned States as well as by the participants themselves. This may kindly be done latest by **<u>22.12.2023</u>**. It is also mentioned that keeping in view the advance ticket booking and other commitments involved in the conduct of the training programme, it would not be possible to change a confirmed nomination to the training programme.

The nominated officers have to be relieved in time to enable them to join the training programme on 22.01.2024 at the Indian Institute of Forest Management (IIFM), Bhopal for the Management Module. Since the MCT programme is no leave training, the officers may be advised not to carry any liability during the training period of 22.01.2024 to 09.02.2024 as absence from the training is not allowed.

The training cost, boarding and lodging expenses of the participant/s will be borne by the Government of India. The Academy would be arranging the boarding and lodging of the officer/s during the entire programme, however the travel expenses for the journey of the participant/s from their respective State/Organization to IIFM, Bhopal and return journey from Dehradun should be borne by the concerned State Government/Organization

Further, as per the Indian Forest Service (Pay) Rules revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008 successful completion of MCT programmes is compulsory for award of Junior Administrative Grade, IInd Super time scale and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be in a position to attend the programme on first nomination only as per the schedule. Failure to attend the said training, without express approval of MoEF&CC, GoI, would mandatorily attract the consequences laid down in the IFS (Pay) Rules, for which this Academy or the MoEF&CC shall not be responsible.
