## Chapter 1

# Launch of the Application

On the launch of the application, a layout as displayed in the Figure 1.1 will be displayed: Here user will get three options

- 1. Click on 'THE INDIAN FOREST ACT, 1927': This will switch the layout where user will be able to see all the chapters of IFA, 1927.
- 2. Click on 'THE WILDLIFE PROTECTION ACT, 1972': This will switch the layout where user will be able to see all the chapters of WPA, 1972.
- 3. Click on 'FOREST (CONSERVATION) ACT, 1980': This will switch the layout where user will be able to see all the chapters of FCA, 1980.

User can select any one of them.

### Chapter 2

## **Application Description**

#### 2.1 Chapters

User can click on any of the acts on the Launch Layout. Following guidance assumes user has clicked "THE INDIAN FOREST ACT, 1927". When user clicks on "THE INDIAN FOREST ACT, 1927" at the launch page of the application, the window showing all the 'Chapters' of 'THE INDIAN FOREST ACT, 1927' will be opened.




Figure 2.1: Layout of all Chapters of an act

#### 2.1.1 Sections





Figure 2.2: Layout of all Sections of a Chapter

#### 2.1.2 Section and Judgement Description

When user clicks on any of the 'Sections', a new window showing following two tabs will get opened

- the content of the 'Section' (Figure 2.3a).
- A list of all judgements related to this Section(Figure 2.3b)


When user clicks on any judgement, a new window is opened which shows summary of the Judgement. The layout of the window is displayed in the Figure 2.3c. When User clicks on the "Full Text" button, the full text of the court Judgement is downloaded from the internet.



#### In this Act-

- (a) "cattle" includes ungulate, camel, buffalo, horse, mare, gelding, pony, bull, colt, filly, mule, ass, pig, ram, sheep, lamb, goat, heifer, bullock and cow;
- (b) "Code" means Code of Criminal Procedure, 1898 (V of 1898);
- (c) "forest' means a reserved forest, protected forest, unclassed forest and village forest and includes wasteland or rangeland;
   (d) "forest land" means a piece of land notified by the Government as the forest land to develop, protect and conserve forest and includes a rangeland and wasteland;
- (e) "forest land use" means use of a piece of land for development, conservation and preservation of a forest;
- (f) "forest offence" means an offence punishable under the Act or the rules;
- (g) "forest officer" means a person appointed by the Government as the forest officer;

When button on the top right (Cloud Button) is clicked, the Application is synchronised with the Cloud database.



Figure 3.1: Main Layout of Application




Figure 3.2: Layout of Sidebar
