Sub: Phase- IV (8) Mid-Career Training programme for Indian Forest Service officers regarding

Sir,

This is to inform you that as a part of civil services reforms approved by the Hon'ble Prime Minister for the three All India Services, viz., IAS, IPS & IFS, the Ministry of Environment, Forests & Climate Change, GoI (MoEF&CC) has approved conduct of Phase IV Mid Career Training programmes for IFS officers of 16-18 years seniority, The eighth course of Phase IV MCT programme for the IFS officers of 1997, 1998 & 1999 batches is proposed to be organized by IGNA in the year 2015 – 16, as per the schedule given as under:-

2. IGNA has finalized the list for nominations to the aforesaid 8th Course of Phase IV programme excluding who has less than three years of service left after the year in which he/she is supposed to undergo MCT as well as those who have not completed PSUC on promotion from SFS. In preparing the list of nominees, roster system approved by MoEF&CC vide letter No.2-9/2006-RT dated 26/11/09 has been followed. Accordingly, names of 105 officers have been finalized for the course, in which the officers at Sl. no. 61 – 105 would be kept in waiting list and would be invited to attend the course, only if any of the first sixty officers drops out or shows his/her unavailability. Otherwise, these officers would be invited in the next course of Phase IV. The complete list whom online registration has been opened as first offer is attached as Annexure – I to this letter. While preparing the list, IFS Civil List 2014 drawn by MoEF&CC has been used as basis. It is, however, likely, that some names especially of those officers inducted into IFS and allotted the relevant YoA, subsequent to preparation of the said civil list, might have not been indicated in the list. In view of this, the concerned administrative department and Cadre Controlling Authority may kindly go through the Annexure- I and inform IGNA about missing names with all particulars pertaining to YoA 1997, 1998 & 1999, which are not figuring in the said nomination list. Academy shall incorporate these names in subsequent list of nominations after getting confirmation from the MoEF&CC. The State Governments are, however, requested to convey approval of participation for all the officers figuring in the list from their states, so that further approval may not be required for inclusion of the officers from Sl. no. 61 to 105 due to drop outs from Sl. no. 1 to 60.

3. As the above training programmes are being organized in association with National/International institutions and also involve two-week foreign visit as well as training at other national level Institutions like IIMs, the participation of individual officer needs to be confirmed well in advance both by the concerned states as well as by the participants themselves.
