This is to inform you that as a part of civil services reforms approved by the Hon'ble Prime Minister for the three All India Services, viz., IAS, IPS & IFS, the Ministry of Environment & Forests, GOI (MoEF) has approved conduct of Phase V Mid Career Training programme for IFS officers of 26-28 years of seniority. Accordingly, the thirteenth course of Phase V MCT programme for the IFS officers of 1986, 87 & 88 batches is proposed to be organized by IGNFA, as per the schedule given as under:

<sup>\*</sup> MCT programme is scheduled to be inaugurated in the evening of 31st August, 2014.

- IGNFA has finalized the nominations for the aforesaid thirteenth course of Phase V programme as per the DoPT guidelines, which provide that a member of service who has less than three years of service left after the year in which he is supposed to undergo MCT, would not be sent for the same. In preparing the list of nominees, roster system approved by MoEF vide letter No.2-9/2006-RT dated 26/11/09 has been followed. Accordingly, names of 85 officers have been finalized for the course, in which the officers at S. No. 71-85 would be kept in waiting list and would be invited to attend the course, only if any of the first Seventy officers drop out or show his/her unavailability. Otherwise, these officers would be invited in the next course of Phase V. The complete list is attached as Annexure - I to this letter. While preparing the list, IFS civil list drawn by MoEF has been used as the basis. It is, however, likely, that some names especially of those officers inducted into IFS & allotted the relevant YoA, subsequent to preparation of the said civil list, might not have been indicated in the civil list. In view of this, the concerned administrative department may kindly go through the IFS civil list and inform IGNFA about missing names pertaining to YoA 1986, 87 & 88 which are not figuring in the said nomination list. Academy shall incorporate these names in subsequent list of nominations after getting confirmation from the MoEF. The State Governments are, however, requested to convey approval of participation for all the 91 officers figuring in the list from their States so that further approval may not be required for inclusion of the officers from S. No. 71 to 85 due to drop outs from S. No. 1 to 70.
- 3. As the above training programmes are being organized in association with National/International Institutions and also involve two-week foreign visit as well as training at other national level Institution like IIM, the participation of individual officer needs to be confirmed well in advance both by the concerned States as well as by the participants themselves. It is also mentioned that keeping in view the international commitments involved in the conduct of the training programme,

it would not be possible to change a confirmed nomination to the training programme except under very emergent circumstances and that too only after the approval of MoEF.

4. You are requested to direct the concerned officers about the programme details and ask them to be in complete readiness. As the Academy has enabled the facility of online registration at its website (<a href="www.ignfa.gov.in">www.ignfa.gov.in</a>), the officers may also be directed to register online immediately. The online registration is compulsory for all participants. The facility can be availed from 18<sup>th</sup> June to 04<sup>th</sup> July, 2014. The most important requirement for all the participating officers would be to get their official passports ready from the Regional Passport Officers located in your state. The officer can either use authority of this letter/respective State Govt. letters for issuance of official passport from Regional Passport Office or approach the IGNFA on an urgent basis to make available the political clearance issued by MEA. The visa formalities can be completed by this Academy/MoEF, only for those officers, who have obtained the official passport in time and have intimated the Academy accordingly. The participating officers may kindly be directed to follow the above requirements well in time.

Further, the States are also requested to take advance action to ensure release of the nominated officers in time to enable them to attend the training programme. During the programme, the participants will be provided single accommodation and under no circumstances the family members would be allowed to accompany during the entire training programme including study visit abroad. This may be brought to the notice of officers so that they do not face embarrassment in the eventuality of return of officers from places of training including foreign countries. Being senior officers of the Country, the officers are expected to observe the decorum, discipline & cultural sensitivities of the foreign countries during entire training to avoid embarrassment to the country & to themselves.

5. Further, it is worth mentioning that the Indian Forest Service (Pay) Rules have been revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008, to make successful completion of these MCT programmes compulsory for award of Junior Administrative grade, II<sup>nd</sup> Super time scale and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be in a position to attend the programme as per the schedule. Failure to attend the said training, without express approval of MoEF, would mandatorily attract the consequences laid down in the IFS (Pay) rules, for which this Academy or the MoEF shall not be responsible.

The reference is drawn to the letter no. 499/MCT/2014/ Ph-V-13 dated 18.06.2014 on the subject of mandatory Mid Career Training Programme (MCTP) participation in Phase V during 2013 and during 2014 to the IFS Officers of Madhya Pradesh State with year of allotment of 1987 & 1988. The participation in MCTP is of mandatory nature and linked with promotion/ increment as per the India Forest Service (Pay) Rules. No exemption is also entertained by the Ministry of Environment, Forests and Climate Change. Three number of chances are made available to an eligible Officer to complete MCT. On postponement of participation after second chance, inclusion of an officer's name for third chance is based on prior concurrence of the Ministry of Environment, Forests and Climate Change, Government of India with the circumstances of non-participation earlier to be recommended by the State Government.

The Indira Gandhi National Forest Academy(IGNFA) is organising MCT Phase V during 2015 from the 29<sup>th</sup> March 2015 to 25<sup>th</sup> April 2015. The IGNFA is also initiating the process of obtaining political clearance for already registered eligible officers on first option availed in 2014 for MCTP in 2015.

Following eligible officers of 1987 & 1988 batch in MP cadrè did not avail the first chance for enrolment online with the Indira Gandhi National Forest Academy, Dehradun (<a href="www.ignfa.gov.in">www.ignfa.gov.in</a>). They are being provided second chance for enrolment in 2015.
