Sub: Nomination of IFS officers for Mid-Career Training (MCT) Phase – III (15) Course – reg.

Madam/Sir,

Please consider that the Mid-Career Training (MCT) III program for Indian Forest Service (IFS) officers of 2012, 2013, 2014, 2015 and 2016 Year of Allotment (YoA), and the IFS officers who have completed Professional Skill Up-gradation Course (PSUC) after induction into IFS on promotion from SFS, is being organized by Indira Gandhi National Forest Academy (IGNFA), as per the following schedule.

2. Eligible IFS officers have been enlisted for the aforesaid program. Accordingly, a list of 124 officers is prepared (Annexure – 'A & B'). It is to be noted that the officers having less than three years of service or those who have not completed PSUC after induction into IFS or who have not completed the IFS professional Training Course or who are suspended from the service are excluded (Annexure – 'C').

The registration is opened for 113 officers (Annexure – 'A').

The 11 officers who have missed the earlier two offers to participate in the MCT Phase – III program have to approach the MoEF&CC, through the State Government for seeking approval for the third offer. The list of such officers is attached as Annexure – 'B'.

3. As the training program is organized in association with National/International institutions, participation of individual officer needs to be confirmed well in advance both by the concerned States as well as by the participants themselves. This may kindly be done latest by **07.04.2025**. It is also mentioned that keeping in view the advance ticket booking and other commitments involved in the conduct of the training program, it will not be possible to change a confirmed nomination to the training program.

The nominated officers may please be relieved in time to enable them to join the training program on 05.05.2025 at the Indian Institute of Forest Management (IIFM), Bhopal for the Management Module. As the MCT program is no leave training, the officers may be advised not to carry any liability during the training period (05.05.2025 to 30.05.2025). Absence from the training is not allowed.

विषय मिड कैरियर ट्रेनिंग (एमसीटी) फेज - III (15) पाठ्यक्रम हेतु भा.व.से. अधिकारियों के नामांकन के संबंध में।

महोदय/महोदया,

सूचित किया जाना है कि पर्या.व.ज.परि. मंत्रालय तथा कार्मिक एवं प्रशिक्षण विभाग, भारत सरकार के वर्तमान दिशा-निर्देश के अनुसरण में 2012, 2013, 2014, 2015 तथा 2016 आवंटन वर्ष वाले भारतीय वन सेवा (भा.व.से.) अधिकारियों तथा रा.व.से. से भा.व.से. में पदोन्नत होने के उपरांत पीएसयूसी पाठ्यक्रम पूर्ण कर चुके अधिकारियों के लिए इन्दिरा गाँधी राष्ट्रीय वन अकादमी (इ.गां.रा.व.अ.) द्वारा मिड कैरियर ट्रेनिंग (एमसीटी) के फेज - III के 15वें पाठ्यक्रम का आयोजन निम्न कार्यक्रमानुसार किया जा रहा है -

2. उपर्युक्त पाठ्यक्रम के लिए योग्य भा.व.से. अधिकारियों को सूचीबद्ध किया गया है। तदुसार, 124 अधिकारियों की सूची तैयार की गयी है (संलग्नक - 'ए एवं बी')। यह ध्यान देने योग्य बात है कि जिन अधिकारियों की शेष सेवा अवधि तीन वर्ष से कम है या जिन अधिकारियों ने भा.व.से. में पदोन्नति के उपरांत व्यावसायिक कौशल उन्नयन पाठ्यक्रम (पी.एस.यूसी.) पूर्ण नहीं किया है या जिन्होंने भा.व.से. व्यावसायिक प्रशिक्षण पाठ्यक्रम पूर्ण नहीं किया है या जो सेवा से निलंबित हैं, ऐसे अधिकारियों को इस सूची में शामिल नहीं किया गया है (अनुलग्नक-सी)।

113 अधिकारियों की सूची, जिनके लिए पंजीकरण खोला गया है, संलग्नक - 'ए' में है।

ऐसे 11 अधिकारी जो एमसीटी कार्यक्रम में भाग लेने के लिए पूर्व में दिए गए दो अवसरों पर चूक गए हैं, वे अपने लिए तीसरे अवसर के अनुमोदन हेतु संबंधित राज्य सरकार के माध्यम से पर्यावरण, वन और जलवायु परिवर्तन मंत्रालय के समक्ष आवेदन कर सकते हैं। ऐसे अधिकारियों की सूची संलग्नक - 'बी' के रूप में संलग्न है।

3. चूंकि उपरोक्त प्रशिक्षण कार्यक्रम विभिन्न विख्यात राष्ट्रीय/अंतर्राष्ट्रीय संस्थानों के सहयोग से आयोजित किए जा रहे हैं, अतः आवश्यक है कि नामित अधिकारी की प्रतिभागिता की पुष्टि स्वयं अधिकारियों और उनके संबंधित राज्यों द्वारा समय रहते कर दी जाए। कृपया यह पुष्टि अधिकतम 07.04.2025 तक अवश्य कर दी जाए। यहां यह उल्लेख करना भी उचित होगा कि इस प्रशिक्षण कार्यक्रम में अग्रिम टिकट बुकिंग तथा अन्य प्रतिबद्धताओं को ध्यान में रखते हुए प्रशिक्षण कार्यक्रम के लिए पुष्ट किए गए नामांकन में अंतिम समय में बदलाव करना संभव नहीं होगा।

नामित अधिकारियों को प्रशिक्षण हेतु समय से कार्यमुक्त किया जाना होगा ताकि वे 05.05.2025 को भारतीय वन प्रबंधन संस्थान (भा.व.प्र.सं.), भोपाल में प्रबंधन मॉड्यूल में भाग लेने हेतु उपस्थित हो सकें। चूंकि एम.सी.टी. कार्यक्रम एक गैर-अवकाश प्रशिक्षण कार्यक्रम है अतः कृपया अधिकारियों को यह सलाह दें कि वे 05.05.2025 से 30.05.2025 की प्रशिक्षण अवधि के बीच कोई जिम्मेदारी न लें क्योंकि उन्हें प्रशिक्षण से अनुपस्थित रहने की अनुमति नहीं दी जाएगी।


4. The training cost, boarding and lodging expenses of the participant/s will be borne by the Government of India. The Academy would be arranging the boarding and lodging of the officer/s during the entire program. *However, the travel expenses for the journey of the participant/s from their respective State/Organization to IIFM, Bhopal and return journey from Dehradun should be borne by the concerned State Government/Organization.*

5. **The participating officers should register at the website (www.ignfa.gov.in) of the Academy latest by 07.04.2025.**

6. Further, as per the Indian Forest Service (Pay) Rules revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008 successful completion of MCT program is compulsory for award of Junior Administrative Grade, IInd Super Time Scale and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be in a position to attend the program on first nomination only as per the schedule. Failure to attend the MCT training, will be dealt with per the IFS (Pay) Rules, for which this Academy or the MoEF&CC shall not be responsible.
