Sub: Nomination of IFS officers for Mid-Career Training (MCT) Phase – III (17) Course – reg.

Madam/Sir,

This is to inform that in accordance with the existing MoEFCC and DoPT, Gol guidelines 17th course of the Mid-Career Training (MCT) III program for Indian Forest Service (IFS) officers of 2012, 2013, 2014, 2015, 2016 and 2017 Year of Allotment (YoA), and the IFS officers who have completed the Professional Skill Up-gradation Course (PSUC) after induction into IFS on promotion from SFS, is being organized by Indira Gandhi National Forest Academy (IGNFA) from **12 January to 06 February 2026**.

2. Eligible IFS officers have been enlisted for the aforesaid program. Accordingly, a list of 142 officers is prepared (Annexure - 'A & B'). It is to be noted that the officers having less than three years of service or those who have not completed PSUC after induction into IFS or who have not completed the IFS probationers' professional Training Course or who are suspended from the service are excluded (Annexure - 'C'). The registration is open for 123 officers (Annexure - 'A'). Of these, 1–100 are in List -I and 101–123 are in List -II. The officers from List -II will be included to the extent that those in List -I are not available.

The 19 officers who have missed the earlier two offers to participate in the MCT Phase–III program have to approach the MoEF&CC through the State Government for seeking approval for the third offer. The list of such officers is attached as <u>Annexure – 'B'</u>.

3. As the training program is organized in association with National/ International institutions, participation of individual officers needs to be confirmed well in advance, both by the concerned States as well as by the participants themselves. This may kindly be done by **19.12.2025**. It is also mentioned that, keeping in view the advance ticket booking and other commitments involved in the conduct of the training program, it will not be possible to change a confirmed nomination to the training program.

The nominated officers may please be relieved in time to enable them to join the training program on 12.01.2026. As the MCT program is a no leave training, the officers may be advised not to carry any liability during the training period (12.01.2026 to 06.02.2026). Absence from the training is not allowed.

4. The training cost, boarding and lodging expenses of the participant/s will be borne by the Government of India. The Academy would be arranging the boarding and lodging of the officer/s during the entire program. However, the travel expenses for the journey of the participant/s from their respective State/organisation to the training venue

- 5. The participating officers should register at the website (<u>www.ignfa.gov.in</u>) of the Academy latest by <u>19.12.2025</u>.
- 6. Further, as per the Indian Forest Service (Pay) Rules revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008, successful completion of MCT program is compulsory for award of Junior Administrative Grade, IInd Super Time Scale and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be in a position to attend the program on first nomination only as per the schedule. Failure to attend the MCT training will be dealt with per the IFS (Pay) Rules, for which this Academy or the MoEF&CC shall not be responsible.
