**Sub: Phase-IV (7) Mid-Career Training programme for Indian Forest Service officers regarding**

Sir,

This is to inform you that as a part of civil services reforms approved by the Hon'ble Prime Minister for the three All India Services, viz., IAS, IPS & IFS, the Ministry of Environment & Forests, GOI (MoEF) has approved conduct of Phase IV Mid Career Training programme for IFS officers of 16-18 years of seniority. Accordingly, the seventh course of Phase IV MCT programme for the IFS officers of **1996 and 1997** batches is proposed to be organized by IGNFA in the year 2014-15, as per the schedule given as under:

IGNFA has finalized the nominations for the aforesaid 7<sup>th</sup> Phase IV MCT programme as per the DoPT guidelines, which provide that a member of service, who has less than three years of service left after the year in which he is slotted to undergo MCT, would not be nominated for the same. In preparing the list of nominees, roster system approved by MoEF vide letter No.2-9/2006-RT dated 26/11/09 has been followed. Accordingly, names of 109 officers have been finalized for the course, in which the officers at S. no. 63-109 are being kept in reserve list and would be invited to attend the course, only if any of the first sixty officers drop out or show his/her unavailability. Otherwise, these officers would be invited in the next course of Phase IV. The complete list is attached as **Annexure - I**. While preparing the list, IFS civil list 2013 drawn by MoEF, has been used as the basis. It is, however, likely, that some names especially of those officers inducted into IFS & allotted the relevant YoA, subsequent to preparation of the said civil list, might not have been included in the civil list. In view of this, the concerned state administrative department may kindly go through the IFS civil list and inform IGNFA about missing names pertaining to YoA **1996 or 1997**, which are not figuring in the said nomination list. Academy shall incorporate these names in subsequent list of nominations, after getting confirmation from the MoEF. The State Governments are, however, requested to convey approval of participation for all the officers figuring in the list from their States, so that further approval may not be required for inclusion of the officers from S. no. 63 to 109 due to drop outs from S. no. 1 to 60.
