Sub: Mid-Career Training Phase-IV (18) Course for IFS officers (2009-2011 YoA) from 13 to 30 April 2026 - reg

Madam/Sir,

This is to inform that in accordance with the existing MoEF&CC and DoPT, GoI guidelines, Mid-Career Training Phase-IV (18) Course for IFS officers of 2009, 2010 and 2011 YoA, and the IFS officers who have completed the Professional Skill Up-gradation Course (PSUC) after induction into IFS on promotion from SFS, is being organized by Indira Gandhi National Forest Academy (IGNFA), as per the following schedule:

Total Duration	Management Module	Line Ministry Module	Forestry Module
13 to 30 April 2026 (3 weeks)	13 to 17 April 2026 (1 week)	20 to 24 April 2026 (1 week)	27 to 30 April 2026 (1 week)

2. Eligible IFS officers have been enlisted for the aforesaid program. Accordingly, a list of 129 officers is prepared (**Annexure – 'A & B'**). It is to be noted that the officers having less than three years of service and those who have not completed PSUC after induction into IFS are excluded. The registration is open for 110 officers (**Annexure – 'A'**).

The 19 officers who have missed the earlier two offers to participate in the MCT Phase IV program have to approach the MoEF&CC through the State Government to seek approval for the third offer. The list of such officers is attached as Annexure – 'B'.

3. As the training program is organized in association with various national institutions, the participation of individual officers needs to be confirmed well in advance, both by the concerned States as well as by the participants themselves. This may kindly be done latest by **20.03.2026**. It is also mentioned that, keeping in view the advance ticket booking and other commitments involved in the conduct of the training program, it will not be possible to change a confirmed nomination to the training program.

The nominated officers may please be relieved in time to enable them to join the training program on 13.04.2026. As the MCT program is a no leave training, the officers may be advised not to carry any liability during the training period (13.04.2026 to 30.04.2026). Absence from the training is not allowed.

4. The training cost, boarding and lodging expenses of the participant/s will be borne by the Government of India. The Academy would be arranging the boarding and lodging of the officer/s during the entire program. However, the travel expenses for the journey of the participant/s from their respective State/Organization to the training venue and return journey should be borne by the concerned State Government/Organization.

5. The participating officers should register at the website (www.ignfa.gov.in) of the Academy latest by 20.03.2026.

6. Further, as per the Indian Forest Service (Pay) Rules revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008, successful completion of MCT program is compulsory for award of Junior Administrative Grade, IInd Super Time Scale and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be in a position to attend the program on first nomination only as per the schedule. Failure to attend the said training, without express approval of MoEF&CC, GoI, would mandatorily attract the consequences laid down in the IFS (Pay) Rules, for which this Academy or the MoEF&CC shall not be responsible.
