Sub: Mid-Career Training Phase – III (19) Course for IFS officers (2014 to 2018 YoA) from 12 October to 06 November 2026 - reg.

Madam/Sir,

In accordance with the existing MoEF&CC and DoPT, GoI guidelines, **Mid-Career Training Phase-III (19) Course** for IFS officers of 2014, 2015, 2016, 2017 and 2018 YoA, and the IFS officers who have completed the Professional Skill Up-gradation Course (PSUC) after induction into IFS on promotion from SFS, is being organized by Indira Gandhi National Forest Academy from **12 October to 06 November 2026**.

2. Eligible IFS officers have been enlisted for the aforesaid program. Accordingly, a list of 107 officers has been prepared (**Annexure – 'A & B'**). *It is to be noted that the officers having less than three years of service or those who have not completed PSUC after induction into IFS or who have not completed the IFS probationers' professional training course or who are suspended from the service are excluded (**Annexure – 'C'**).*

Registration is open for 92 officers (Annexure 'A'**).** Of these, 1–60 are in List- I and 61- 92 are in List - II. The officers from List – II will be included to the extent those in the List – I are not available. ***The 15 officers who have missed the earlier two offers to participate in the MCT Phase – III program have to approach the MoEFCC, through the State Government, to seek approval for the third offer. The List of such officers is attached as Annexure – 'B'.***

3. As the training program is organized in association with National/International institutions, participation of individual officers needs to be confirmed well in advance both by the concerned States as well as by the participants themselves. This may kindly be done by 04.09.2026 at the latest. It is also mentioned that keeping in view the advance ticket booking and other commitments involved in the conduct of the training program, it will not be possible to change a confirmed nomination to the training program.

The nominated officers may please be relieved in time to enable them to join the training program on 12 October 2026. As the MCT program is a no-leave training, the officers may be advised not to carry any liability during the training period (12 October to 06 November 2026). Absence from the training is not allowed.

4. The training cost, boarding and lodging expenses of the participants will be borne by the Government of India. The Academy will arrange the officers' boarding and lodging for the entire program. *However, the travel expenses for the participants' journey from their respective State/Organization to the training venue and return should be borne by the concerned State Government/Organisation.*

5. **The participating officers should register at the website (www.ignfa.gov.in) of the Academy by 04.09.2026 at the latest.**

6. Further, as per the Indian Forest Service (Pay) Rules revised vide notification no. 20011/1/2006-AIS-II dated 21.02.2008 and its amendment through IFS (Pay) Second Amendment Rules, 2008 vide notification no. 14021/3/2008-AIS-II dated 27.09.2008, successful completion of the MCT program is compulsory for the award of Junior Administrative Grade, IInd Super Time Scale, and further increments to the concerned officers. Therefore, it would be the responsibility of the concerned State Government and the officers themselves to be able to attend the program on the first nomination only, as per the schedule. Failure to attend the MCT will be dealt with per the IFS (Pay) Rules, for which this Academy or the MoEF&CC shall not be responsible.
