**2. अधिकारियों हेतु निर्देश:**

- अधिकारी अपने कार्यानुभव के आधार पर शोधपत्र/प्रस्तुति प्रस्तुत करने के लिए स्वेच्छा से योगदान दे सकते हैं। ऐसे शोधपत्र/प्रस्तुतियाँ प्रशिक्षण कार्यशाला के आयोजकों को अग्रिम रूप से भेजी जा सकती हैं।



5. वे अधिकारी जो नामांकन एवं पंजीकरण के बावजूद प्रशिक्षण में भाग नहीं लेंगे, उन्हें भावेष्ट के प्रशिक्षण कार्यक्रमों से वंचित (ब्लैकलिस्ट) कर दिया जाएगा।
